Eligibility All Regional Artists: Midwest Artists within reasonable driving distance. All media will be considered. Maximum of three submissions. Original work only. Work must not have been exhibited in the USG Main Gallery within previous two years. Work over 75 lbs. must be hand delivered, installed and picked up by the artist or representative. Work which requires more than 1 hour to install must be installed by artist.

Jury Fee \$25 non-refundable jury fee is required per artist. Please make checks payable to Union Street Gallery, "Objects of Affection".

Submission of Artwork Artwork must be ready to install. 2-D work must be prepared properly for hanging, no saw tooth hangers. 3-dimensional work must sit sturdily on pedestal or floor. All work remains on exhibit for duration of show.

Rules for Entry Curators reserve the right to refuse work that does not meet the criteria, is damaged, or considered too fragile for exhibit. Artwork must be hand delivered to the Gallery on August 20-21, between the hours of 12pm and 6pm. Checks are payable to Union Street Gallery. Declined artwork must be picked up on August 25-26, between the hours of 12pm and 6pm. If necessary, special arrangements can be made to pick up work Saturday, August 28th between 12 and 4pm.

Union Street Gallery is Responsible for

1. Installing / displaying artwork professionally
2. Inviting over 1800 individuals who subscribe to USG e-mail news
3. Staffing gallery premises during regular hours
4. Sending press releases to media outlets

Artist is Responsible for

1. Hand delivering artwork on August 20-21, between 12 and 6pm
2. Insuring artwork on exhibit while at USG; USG provides no insurance for artwork while on premises
3. Forwarding email invitations from USG to personal email list
4. Picking up artwork on September 25 between 12 and 6 pm; work left after 7 days beyond scheduled pick up date will be charged \$5 daily fee. After 60 days artwork becomes property of USG
5. Being professional and cooperative in adhering to USG guidelines

Sales All sales are made directly to the artist. Artist is responsible for state/local taxes. A 30% donation to Union Street Gallery, a not-for-profit 501(c)3 organization, from any sale resulting from the exhibition is requested. Donations are tax deductible, consult your tax advisor.
